SUPPORTING SUPERFUND REFORM BILL H.R. 2500

WHEREAS, current Federal legislation under the Comprehensive Environmental Response, Compensation and Liability Act places undue hardship on hundreds of local governments caught up in a web of strict interpretation of regulations; and

WHEREAS, H.R. 2500 in the United States Congress Commerce Subcommittee on Hazardous Waste provides for liability relief of owners and operators of municipal landfills that accepted ordinary solid waste which was disposed of with industrial waste; and

WHEREAS, the Sussex County Council operated six household waste landfills; and

WHEREAS, the Sussex County Council believes current EPA regulations were never designated to include landfills that accepted household waste with the same criteria as industrial landfills; and

WHEREAS, the blind application of EPA standards to all facilities in the Superfund Program has already cost Sussex County more than \$2.2 million in technical and legal fees; and

WHEREAS, H.R. 2500 requires the cleanup of Superfund landfills to be paid entirely by the Federal government and would also relieve liability for past expenses;

NOW, THEREFORE,

BE IT RESOLVED that the Sussex County Council, having met in public session, encourages the Delaware Congressional representatives in Washington, D.C., to support H.R. 2500 to allow for the easing of the liability of the taxpayers of Sussex County.
