## RESOLUTION NO. R 023 95

RATIFYING AND CONFIRMING ACTION TAKEN BY COUNTY ADMINISTRATOR IN CONNECTION WITH \$20,825,000 WASTEWATER REVENUE REFUNDING BONDS (WEST REHOBOTH EXPANSION SEWER PROJECT) SERIES 1995

WHEREAS, pursuant to the laws of the State of Delaware, particularly Chapter 67 of Title 9 of the Delaware Code, as amended, Ordinance No. 948, enacted January 11, 1994, and a Trust Agreement dated as of April 1, 1994, with Wilmington Trust Company (the "Trustee") as supplemented by Supplemental Agreements No. 1 and 2, both dated as of April 1, 1994 (the Trust Agreement as so supplemented hereinafter referred to as the "Original Trust Agreement"), the County Council of Sussex County, Delaware (the "County") issued its \$19,000,000 Wastewater Revenue Bonds (West Rehoboth Expansion Sewer District), Series 1994 (the "1994 Bonds") and its \$17,000,000 Wastewater Revenue Subordinate Obligations (West Rehoboth Expansion Sewer System) Series 1994 SRF (the "SRF Obligations");

WHEREAS, in connection with the issuance of the SRF Obligations, the County entered into a Financing Agreement with the Delaware Water Pollution Control Revolving Fund, acting by and through the Department of Natural Resources and Environmental Control ("DNREC") dated as of April 1, 1994 (the "Financing Agreement");

WHEREAS, pursuant to Ordinance No. 1042 adopted July 18, 1995 (the "Ordinance"), County Council authorized the issuance of Sussex County Wastewater Revenue Bonds for the purposes of refunding all or a portion of the 1994 Bonds;

WHEREAS, pursuant to the Ordinance, the County Administrator was authorized to negotiate the sale of the aforesaid obligations upon such terms and conditions as he determines shall be in the best interest of the County and he is further authorized and directed to take such other action on behalf of the County as deemed necessary or desirable to effect the purposes of the Ordinance and the issuance of said obligations;

WHEREAS, acting pursuant to the Ordinance, the County Administrator has negotiated (i) the sale of \$20,825,000 of the County's Wastewater Revenue Refunding Bonds (West Rehoboth Expansion Sewer Project) Series 1995 (the "Bonds") upon terms described in (1) a Contract of Purchase (the "Contract of Purchase") dated November 17, 1995, between the County and Wheat First Butcher Singer (the "Underwriter") and (2) the Original Trust Agreement as supplemented by Supplemental Agreement No. 3 dated as of December 1, 1995 ("Supplemental Agreement No. 3", the Original Trust Agreement as so supplemented hereinafter referred to as the "Trust Agreement") and (ii) a First Amendment to Financing Agreement dated as of December 1, 1995 (the "First Amendment"); and

WHEREAS, the County has received the report of Jones, Hayward & Lenzi, Certified Public Accountants, to the effect that the funds to be deposited under the Escrow Deposit Agreement (the "Escrow Agreement") dated as of December 1, 1995 by and among the County, the Trustee and Wilmington Trust Company, as Escrow Agent, together with the earnings thereon but without any reinvestment earnings, will be sufficient to provide for the payment of principal and interest on the 1994 Bonds when due through June 15, 2004 and for the redemption on June 15, 2004 of all 1994 Bonds maturing after that date;

WHEREAS, the County Administrator has reported that the gross savings in the annual debt service payments resulting from the refunding has been determined to be \$646,029 and the present value of such savings, discounted at the yield on the Bonds, has been determined to be \$565,368, as more particularly described in Exhibit A hereto;

WHEREAS, the County Council wishes to ratify and confirm actions taken by the County Administrator in connection with the sale and issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Sussex County, Delaware, as follows:

- County Council hereby ratifies and affirms the action taken by the County Administrator in connection with the sale and issuance of the Bonds including entering into the Contract of Purchase with Wheat First Butcher Singer, preparing and circulating a Preliminary Official Statement and a final Official Statement, committing to the purchase of bond insurance from MBIA Insurance Corporation, appointing Wilmington Trust Company to serve as Escrow Agent under the Escrow Agreement, providing for the early redemption of the 1994 Bonds pursuant to the Escrow Agreement and negotiating the First Amendment with DNREC providing for a sharing of the refunding savings.
- This Resolution shall be effective immediately upon its adoption.
